12. Elections Related Resource Policy

Recommendation

WHEREAS pursuant to Section 88.18 of the Municipal Elections Act, 1996, local boards must establish rules and procedures respecting the use of board resources during election campaign periods before May 1 in the year of a regulation election, and

WHEREAS on May 7, 2018, the Crime Prevention Ottawa's Board of Directors approved a motion stating that the "Crime Prevention Ottawa Board adopts the City of Ottawa's Election-Related Resources Policy as required by Section 88.18 of the Municipal Elections Act, 1996, effective May 1, 2018," and

WHEREAS the City of Ottawa's Finance and Economic Development Committee approved changes to the Election-Related Resources Policy (ERRP) on March 1, 2022 and the revised ERRP will be considered by City Council at its meeting of March 23, 2022;

THEREFORE be it resolved:

That in compliance with Section 88.18 of the MEA, the CPO follow the City of Ottawa's updated ERRP for the 2022 Municipal Elections and until such

time as the Board of Directors determine that a standalone CPO ERRP is necessary.
